- (3) Self addressed envelope with postal stamp is required to be submitted.

## **GENERAL RULES & REGULATIONS**

- 1. No Application will be considered unless it is duly filled up & accompanied by attested copies of all relevant certificates. Incomplete application in any form will be summarily rejected. In case of non-compliance of any of the details relevant to the application form, the applicant shall stand to lose right of any kind of representation regarding merit list as well as admission.
- 2. Eligibility: H.S.C. (Science passed with Physics, Chemistry and Biology or mathematics subjects from Govt. recognized state/central/other equivalent board with at least 50% marks (selection to the course will be strictly on merit basis).
- 3. Admission: Admission will be given strictly on merit basis.
- 4. **Merit List:** A provisional common merit list will be displayed on respective Institute's website. Student has to communicate in writing regarding any discrepancy in provisional merit list within 3 days of its display. No separate individual intimation will be given to candidate for this purpose.
- 5. Reservation: Admissions will be subject to Government rules on 'Reservation policy' from time to time.
- 6. Fees: Selected Candidates will have to pay Rs.20,000/- fees at the time of admission only. Fees once paid will not be refunded under any circumstances.
- 7. **Documents:** Relevant documents [self attested] for the proof of age, proof of residence, aadhar card, educational qualifications, proof of educational Institute (School) No. of attempts, appropriate certificate regarding reservation, non inclusion of creamy layer for SEBC students, etc should be attached with application.
- 8. **Scrutiny of documents:** Original documents should be produced at the time of personal interview for scrutiny and whenever demanded by the institution authority.
