#### <u> Part – 1</u>

- 1. Technical Bid (Check List) should be submitted online.
- 2. The eligibility of the bidders will be evaluated by the Committee on the basis of documents submitted by the Bidders. The Financial Bids will only be considered for those Bidders who qualify the eligibility criteria and other terms and conditions lay in the tender.
- 3. Committee of THE GUJARAT CANCER & RESEARCH INSTITUTE, AHMEDABAD may also ask for clarifications and explanations. The report of the committee shall be final and binding upon the bidder. The bidder should also note the terms & conditions particularly those relating to the , E.M.D., Payment terms, Penalty, Contract terms in which no relaxation will be given.
- 4. The tenders will be opened online on the date, time specified in tender notice.
  - (a)In the first instance, only "technical bid" will be opened online on the date of opening the tender and taken into consideration for finalization. Subsequently, the "commercial bid" will be opened online only for those bidders whose quotations satisfy the technical requirement of the indenter and are otherwise acceptable.
  - (b)Back out from tender at any interim level during tender processing: -
  - Once the tenders are submitted it will be the responsibility of the bidder not to escape halfway directly or indirectly by way of raising any problems.

- 5. The Authorized Signatory may seek any clarification / explanation / documentary evidence related to offer at any stage from bidders if required. The Authorized Signatory of THE GUJARAT CANCER & RESEARCH INSTITUTE, AHMEDABAD reserves the right to consider or reject any or all tenders or close the tender enquiry without assigning any reason at any time at any stage.
- 6. The tender will be accepted if Tender Committee is satisfied with the quoted price and past performances of bidder.
- 7. - 3. IN NO CASE, RATES SHOULD BE QUOTED IN ANYWHERE EXCEPT ONLINE IN PART-II i.e COMMERCIAL BID.
- 4. Bid Currency: Prices shall be quoted in Indian Rupees only.
- 5. In no case, rates should be quoted anywhere except in commercial bid. The tender will be summarily rejected without any further processing or reference if the rates are quoted or written at any place except at the relevant place in commercial bid. The rates quoted shall be presumed, in all cases, as the net price inclusive of all duties and sundries. No payment against any duties will be considered under any separate heading under any circumstances. Bidder will also have to guarantee regular and timely services.

#### 5. REJECTION OF TENDER

The tender is liable for rejection due to any of the reasons mentioned below:

- 2 Tender documents are unsigned OR not initialled on each page or with unauthenticated corrections.
- 3 Submission of tender documents in unsealed envelopes.
- 4 Tender documents are not submitted in separate envelopes as per conditions and the envelopes are not super scribed with details of the tender enquiry and part enclosed.
- 5 Non-payment of Earnest Money Deposit
- 6 Non-submission of required documents as required.
- 7 Conditional and / or vague offers
- 8 Unsatisfactory past performance of the bidder.
- 9 Rates have been shown elsewhere than Part-II.
- Submission of misleading / contradictory / false statement or information and fabricated / invalid documents.
- 11 Non execution of agreement within stipulated time period.
- 12 Non submission of Tender Fee.

#### Other terms & conditions

- 1. Approved bidder cannot sub contract/lease or sell this contract to other bidder.
- 2. All Items are to be scrap on "As and where is" basis.
- 3. The prospective bidders are advised to inspect the material / stores at our works site during working hrs. of store offices before submitting their offers.
- 4. Any conditional offer is not binding to the Institute and is liable to be rejected.
- 5. The decisions of the institute's in case of dispute will be binding to the bidders.
- 6. Approved bidder has to collect the scrap within three days from the receipt of acceptance letter given by The Gujarat Cancer & Research Institute.
- 7. Approved bidder has to pay approximate cost of scrap in advance, failing which security deposit will be forfeited and bidder will be blacklisted.
- 8. For Scrap Item Visit is only available for Ahmedabad & Vasna Center only other center same rate will be applicable.
- 9. Approved bidder has to collect the scrap by their own expenses from the Gujarat Cancer & Research Institute and, COC Vasna Cancer Centre, Siddhpur, Rajkot, Bhavnagar Transportation charges or any other charges will not be paid by the institute.
- 10. Bidder has to be present at the time of collection of scrap. If it is not possible for the owner, authorized and responsible person of the firm has to be present at the place. Bidder has to agree on the weight measured by the institute. No arguments will be accepted on it.
- 11. If the bidder will fail to collect the scrap, Security deposit will be for feited and scrap will be sold to second highest bidder.
- 12. Bidder will be fined for the breach of tender terms and loss incurred to the institute will be debited from security deposit. Contract will be Cancelled and bidder will be blacklisted.
- 13. Tax is extra as Per applicable rates.
- 14. If any Damage occurs to institute or Item, While taking condemn Item, Bidder is able to pay for that damage to the institute.
- 15. Weigh bridge must be approved & Certified by Weight & Measure department.
- 16. Institute has all the Rights to do Weight of Scrap Item at any Two Weight bridge and Its Cost is it bearing by the bidder.

- 17. It will be bidder's responsibility to load Scrap with his Vehicle which must be weighed before (when empty) and after (when full) cost of weighing will be borne by the bidder.
